In follow up to your below public record request for "... a copy of any/all police reports, dispatch records, witness statements, 9-1-1 tapes, and offense/incident reports in connection with the death of 13 year old Sinzae Reed," our office has released the October 17, 2022 Columbus Police Department Incident Report. We have no other records responsive to your request as any investigative records or information involving the death of Sinzae Reed that are in the possession of this office are exempt from release under the CLEIRs exemptions to the Ohio Public Records Act as they involve an ongoing criminal investigation.
