MEMORANDUM IN SUPPORT OF DEFENDANT BP HUSKY REFINERY'S MOTION TO DISMISS

Plaintiff's Complaint asserts claims against "BP Husky Refinery" and four different unions seeking a full pension and \$10 million in monetary and punitive damages. Plaintiff does not actually assert any concrete legal claims, but rather general grievances laced with conspiracy theories dating back roughly twenty years. Because Plaintiff does not assert any cognizable legal claim against BP Products, the Court should dismiss his claims against BP Products with prejudice.

I. BACKGROUND AND PROCEDURAL HISTORY

BP Products North America, Inc. ("BP Products") operates the Husky Refinery in Oregon, Ohio, which supplies fuel to locations throughout the Midwest. The Husky Refinery itself is not an independent legal entity. BP Products has both its own employees and contractors working at the Husky Refinery. It does not, however, have any record of ever employing Plaintiff or having Plaintiff work at the Husky Refinery (or elsewhere) as a contractor. In his Complaint, Plaintiff does not allege any facts to support a conclusion that he ever worked at the Husky Refinery.

Plaintiff nonetheless filed the Complaint against the Husky Refinery and the Union

Defendants on May 27, 2022. As articulated in BP Products' response to Plaintiff's Motion for

Default Judgment, Plaintiff did not properly serve BP Products with the Complaint. (See Resp.

to Mot. for Default Judgment, filed Dec. 19, 2022). This failure resulted in BP Products being

unaware of the pendency of this case and Plaintiff, upon the Court's Order, moving for default

judgment. When BP Products became of that motion and, by extension, the case itself, BP

Products retained undersigned counsel and opposed the Motion for Default Judgment. The Court

denied Plaintiff's Motion for Default Judgment on January 31, 2023.

II. <u>LEGAL ARGUMENT</u>

A. Standard of Review

Rule 8(A) of the Ohio Rules of Civil Procedure imposes a requirement on plaintiffs to include in their complaint "a short and plain statement of the claim showing the party is entitled to relief. Civ. R. 8(A). Rule 12(B)(6) of the Ohio Rules of Civil Procedure provides that the Court can dismiss a complaint at the pleadings stage when the plaintiff fails "to state a claim upon which relief can be granted." Civ. R. 12(B)(6).

A complaint should be dismissed when "it appears beyond doubt from the complaint that the plaintiff can prove no set of facts entitling him to recovery." Menorah Park Ctr. for Senior Living v. Rolston, 164 Ohio St. 3d 400, 2020-Ohio-6658, 173 N.E.3d 432, ¶ 43.

B. Plaintiff Does Not State a Cognizable Legal Claim

Plaintiff's Complaint does not meet Rule 8(A)'s requirement because it does not state any cognizable legal claims and instead recites often-incoherent grievances with Plaintiff's personal financial situation and work history, among other topics. He does not include any allegations of wrongdoing by BP Products at all. In fact, BP only comes up twice in the Complaint:

- "Judge Mandros was corrupt rigging case dismissed 2016 filed two million against BP Refinery and Local 50"; and
- "These damages never stop and 2012 Foreman Greg Paul from Local 50 said a dozen guys and he were turned away the gate a job BP Refinery discrimination as FBI rigs people sex game pairs jobs."

These allegations plainly do not support any claims against BP. The first allegation appears to suggest unethical behavior by Judge Mandros in a 2016 case. Setting aside the utter lack of evidence for this inflammatory claim of impropriety, it does not suggest that BP acted wrongly in this instance at all. The second allegation is not comprehensible. It appears to recite the experiences of Greg Paul and "a dozen guys" (but, crucially, not Plaintiff) in 2012. Plaintiff would not have suffered harm from BP Products turning away others at the gate, even if doing so were unlawful. BP Products is unable to discern the meaning of the allegations about the FBI and sex games, but those allegations surely would not support a claim against BP Products.

There is no set of facts that Plaintiff could prove that would show he is entitled to relief on these claims. He does not make any intelligible allegations of wrongful conduct by BP Products, and thus will not be able to show that he is entitled to any recovery from BP Products. This alone is sufficient to dismiss his claims under Ohio law. But to the extent the Court reads a claim into these allegations, the claim would almost certainly be time-barred. *See* R.C. 4112.052(C) (statute of limitations for discrimination claims is two years under Ohio law). The first allegation is dated to roughly six years prior to Plaintiff filing the Complaint and the second, roughly a decade.

III. CONCLUSION

The Court has already recognized that, on this Complaint, Plaintiff cannot sustain claims against the Union Defendants. His claims against BP Products are even more sporadic and worthy of dismissal. For the reasons, BP Products respectfully requests that the Court







Dear Brothers and Sisters,

As you have heard in recent Newsletters and Union meetings Local 421 has a serious problem on projects being done in our jurisdiction. Absenteeism, members being referred to work and failing to pass drug screenings. Although our pass/fail rate has improved for drug screenings, our average absenteeism on projects is at a very disappointing 25%. It has now reached the point that Contractors who have previously worked in our area have decided to no longer pursue upcoming projects in North and South Carolina.

At a time when North and South Carolina have more opportunities to put our members to work than ever before, I am finding it very difficult to find Contractors to look at upcoming projects because of our failure to refer them craftspeople that will be at work every day. Unfortunately Local 421 has some members that think "what's the big deal with me missing work? The contractor doesn't pay me when I'm out." They can't understand that a Contractor bids a project to be completed at so many "productive" man-hours and a completion date. When someone misses work, that's a day of non-productive man-hours and that affects the schedule for that project. Local 421 cannot survive with a reputation like this. He or she is hurting Local 421, but most of all their hurting you and your family. So the next time you notice one of our UA members missing time during the week and working on the weekend for premium pay, ask them if they are going to help you feed your family when you're unemployed because Union Contractors no longer want to bid work in North and South Carolina. Local 421 has the reputation of having more members than most, with poor work ethics.

At our last Union meeting, the Brothers and Sisters present agreed that something should be done to fix this serious problem, and they all agreed that each member of Local 421 has a responsibility to call out and remind other members that do not understand the seriousness of these issues and how their actions were affecting every member of Local 421, and not just them.



LETTER OF DETERMINATION

Joseph Marion Emerson v. Auto Warehousing Co. TOL72(39899)05282019722A-2019-02373C

FINDINGS OF FACT:

Charging Party filed a charge of discrimination with the Ohio Civil Rights Commission ("Commission") alleging Respondent engaged in an unlawful discriminatory practice. All jurisdictional requirements for filing a charge have been met.






- Isabella Rose Giannulli, 22, was seen enjoying some downtime with friends on the beach at the five-star Rosewood Miramar Hotel in California Saturday

 she is sharing a cell with three other



Authority For Civil Cover Sheet

The JS 44 civil cover sheet and the information contained herein neither replaces nor supplements the filings and service of pleading or other papers as required by law, except as provided by local rules of court. This form, approved by the Judicial Conference of the United States in September 1974, is required for the use of the Clerk of Court for the purpose of initiating the civil docket sheet. Consequently, a civil cover sheet is submitted to the Clerk of Court for each civil complaint filed. The attorney filing a case should complete the form as follows:

- **I.(a) Plaintiffs-Defendants.** Enter names (last, first, middle initial) of plaintiff and defendant. If the plaintiff or defendant is a government agency, use only the full name or standard abbreviations. If the plaintiff or defendant is an official within a government agency, identify first the agency and then the official, giving both name and title.
 - (b) County of Residence. For each civil case filed, except U.S. plaintiff cases, enter the name of the county where the first listed plaintiff resides at the time of filing. In U.S. plaintiff cases, enter the name of the county in which the first listed defendant resides at the time of filing. (NOTE: In land condemnation cases, the county of residence of the "defendant" is the location of the tract of land involved.)
- (c) Attorneys. Enter the firm name, address, telephone number, and attorney of record. If there are several attorneys, list them on an attachment, noting in this section "(see attachment)".
