

Memorandum for Motion of Reconsideration

For the Facts That the Dry docked vessel that is at ~14512 Glendale Avenue Cleveland Ohio Republic Near. [44128]- that is the birthright and private property of the Relator that is claimed in the UCC-1 Financial Statement with the receipt number that is \*OH00262765531\* was severely damaged by drunken drivers on both August 25th, 2022 and June 7th, . 2023 as shown in the attached evidence- And as the result of the damages the property- The relators wife is has been displaced and the property is at risk of the state of being condemned by the City of Cleveland due to the presumed abandonment and lack of caretaking of the property that was and is the sole responsibility of the Relator- As well as the fact that the Animal Protection League does continuously harass and threaten the Common Law Wife of the Relator as well as the Relator as the result of the Relator's abrupt absence and inability to properly care for his animals that are the product and property of the Realtor's registered business that is "RedSea Kennels Cle" that is registered via the State of Ohio
