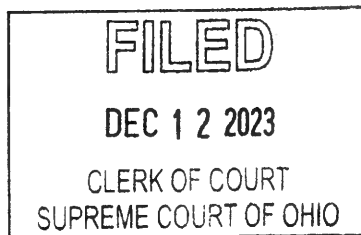

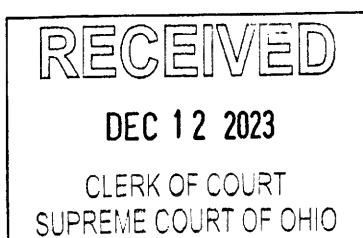

Dear Ohio Supreme Court I am writing these letters to you requesting a writ For Habeas Corpus which will be on my cover page. I have been targeted out because of my political and financial religious family heritage that goes back to at least 1700's to the battle of Bibb Furnance 1865 The first governor of Alabama William Wyatt Bibb. The second governor of Alabama Thomas Bibb. First lady senator of Alabama Dixie Bibb Graves. Governor of Alabama David Bibb Graves Caldwell + Coldwell banking realty and auto sales. My grandmother was Betsy Caldwell Bibb was from Greenbrier West Virginia which was kidnapped back when my dad was a kid Jack Lee Bibb he was born in 1935. The Bibb Coast Guard Cutter W31 ocean station bravo was laid to rest off Key Largo as a treasure in 1985

Obviously there are things that I own I had no idea about. They have voice to skull/remote viewing / Synthetic telepathy which is known as accusik kitty from the sixties where they have FM + TV frequencies in my body and in my inner ears. I have a visible RFID computer chip on top of my right hand. It's also deeply tied in to a case named LaBella vs FBI 2011 an affidavit filed by murdered FBI director Ted Gunderson and Senato John DeCamp which ties in to me being a victim of The Conspiracy of Silence video The Franklin Cover up which is tied to child molestation which I have been a victim of since at least the 80's. In the video Conspiracy of Violence one of their victims talked about how they would get young boys drunk and drugged up, have two guys stand together put their arms together then drop cigarettts down between their arms. Two of mine were cigars of the three scars on my arm in the 80's

In reseaching this stuff I had found out most of the victims has been murdered or disappeared or locked up. I also found out that somebody at the bottling factories of alcohol and other products has been tainted then shipped off to different areas of the cities tied in to MK Ultra Mind Control Experiments and I am one of their test subjects, at least till 1960's and so was my mother at OSU tied into LSD testing on human beings. There is a lot more tied to me and my family. I was also running for mayor this year and I was also railroaded out of that claiming I also was a criminal falsely accused of aggravated drug trafficking. In 1991, how it happened, my ex girlfriend Brenda Montgomery which I was with for 27 years, her niece Kelly Johnson was dating a guy said he was from the army, by the name Brian McDaniels

which I later learned that was not his real name. I had learned that he was a paid informant that stayed out of jail for getting other people involved what they call a scenario. He came to me one day in December 1991 and asked if I could get him a \$20 bag of pot. A little while later, if I could get him a \$30 bag of pot. There was a guy that lived upstairs from me in an apartment, that told me if I ever need any personal smoke he had a little. His name was Amos Dotson. He came to me a few days later than that and asked me if I could get him an ounce. He had a black guy with him by the name of Enoch White. Brian handed me two hundred dollars, so I went upstairs and got him an ounce. I found out later that the 200.00 was pre marked money, there was also 2 1/4 inch little balls of what they called hash and it wasn't by the police lab reports.

On January 2, 1991 I believe it was early evening I heard a bunch of windows breaking upstairs a bunch of racket. I looked outside and seen like 15 guys dressed in black maybe more all them holding what looked to be military grade rifles. This was in German Village Columbus Ohio. on third or Fourth Street about 3 blocks south from Thurman Street South of the Engine House restaurant. From what I understand the neighbors filed complaints about their un-professionalism the way they where shuffling rifles around in the streets. They shot 12 windows out of the apartment upstairs So I sit back down and they shot 12 windows out of my house downstairs, busted in the door came in and threw me and Brenda on the floor, dragged us in front of the couch face down and roughly put nylon straps on our hands behind our back

They said there were warrants on me that they didn't let me know about. They took me and put me in a cruiser. While I was out there I watched them go after my band equipment that was stored on the third floor where I was with the Terry Farley Band. I watched them drag my 2 4' x 4' audio cintron down the stairs that's where they all went as soon as they secured the house. Then started to drag all the equipment down the stairs. A friend of ours brought the receipts there then they had to carry it all back up. I have never had anything illegal in that apartment when I got out of jail I think the next day I went to the house and it was tore completely up unlivable. Out of all the places I rented I've always had a good rental record. I even ran an eviction company I was autorised by Tim Kelly properties and management to file evictions in the courthouse and bailaf at the property. One I remember was on Trivate St on E side Columbus Oh.

Our band and some of the people we did jobs for had nothing to say about us but good. My band the Terry Farley band that I managed and play sound for 4 years which was also The Wild Eagle Band The Josie Wales Band The Liquid Blue Band The Still Wild Band We opened up on the Santa Maria grand opening. A ship they put on riverfront downtown Columbus. We did the Jerry Lewis Telethon ran the whole show all night long on T.V. Did the policeman benefit in 2014 a big show outside Pataskala including benefits and Toys for Tots, I was told of things and/or property that I might own, tied into Probate Court in 1974 when I got ran over by a Van and it ended up in there with 4 bank accounts and multiple guardians of my account including some of the military, possibly tied in the Ruby Ridge incident where the ATF and others was trying to steal a man's property

I was taken to jail 3 times for the same charges everytime. The 3rd time they came to my mothers house on E side Columbus Ohio off Lynwood I heard a knock at the door looked out to open it and I could see the informants face Brian Mc Daniels I opened the door he pushed his way thru the front door with about 7 cops behind him saying these are my guys. They shut the electric off my brother Timmy was upstairs they pulled ~~to~~ a gun on him I asked them to please get that informant out of my mothers home they arrested me for the same charges again which was double jeopardy. At the beginning of this the courthouse sent me a letter that no charges were going to be filed In a little while after that they sent me a letter saying I was being charged with aggravated drug trafficking. When I went to court in 3 or 4 weeks I was talking to Prosecutor Miller

He told me a couple of days before the trial if I would agree to probation for selling a little bit of pot to have a small bag of pot. It actually helped me stop drinking. I was very displeased with my lawyer Doug Shaw because when we got in the court room Prosecutor Miller that made the plea bargain with me for propation was nowhere around & guys I never seen before stood up and told the Judge that I didn't learn my lesson and their exact words was throw the book at him. In 1975 governor Rhodes decriminalised marijuana in the state of Ohio. anything under 100 grams was a minor mistemeanor no jail time 250.00 Fine The Judge looked at me and said 23 years in prison. My attorney I barrowed money to pay for would not let me say a word. It was reduced to 3 years in PCI prison After 2 1/2 weeks of being there my ex-girlfriend Brenda finally got my attorney and Prosecutor Miller together

Prosecutor Miller signed the original agreement for probation and they let me walk out of the prison to go home. I had found documents that we were a political Family a religious Family years ago a little later in 1991. I had seen the lead narcotic officer Enoch White on the front page of Columbus Ohio newspaper walking a little ole Lady across the street. someone had told us that was cause of shanigans that went on when they raided my apartment. I also found out there's George Hunter White that was involved in a project called midnight climax. The pattern of being stalked and incarcerated, and unlawful detention since I was 15 years old. In 1974 I was hanging around some older guys around Parsons. All of sudden a bunch of cops with a helicopter appeared. I didn't know any of the people that was around me. I got took to police dept. at 15 years old charged cause they said I had the keys to a car

Come to find out The Lady that owned the car ~~th~~ said it was not me, the guy trying to hot wire the car was taller than me and had longer hair So the part about the key was a fabrication because they trying to hot wire burned up battery and alternator and I had to pay for those. In 1978 they took my drivers license for 20 1/2 yrs. and pulled me over 5 times for it and took me to jail. Around 1979 or so I was at a big night Club in the Send of Columbus called peppermint tiger, I had lit a roach of marijuana I was standing using the rest room and a cop patted my back I turned and it was an officer took me to jail for 1 hit of that joint 1/2" long I spent 5 days in jail for that There are several incident like that ~~th~~ led up to 1991 for instance 3 incidence with the state of ohio mental health hospitals

At the end of 2014 I called netcare and got an answering machine. I told netcare that I use to live down the street on Hartford Street and had constant problem with the neighbor 3 door W of me known as The Connors at 662 E Hartford St. Columbus 43206 I have had police reports on them where cops came out to the house and took a report I was not the only one. It was all about looking in my window and threatening to come in the house. I told netcare on answering machine when that was going on I was with a lady named Betty Graves Right before that incident she was on a 5 day Jury trial called The Mask Bank Robber Case They were stalking us then too. So I didn't hear nothing back from Netcare So I called them the next day got answering machine

I left message on machine that if something happens to my mother or my property I'm going to sue you people. The next day lady from netcare in a paddy wagon with 2 officers came to my mothers house at 9:20 Kyle Ave Columbus Oh 43207, And after 20 mins. talking to me the officers + the lady from netcare told me I have the right to do what I need to protect my family + property about 15 hrs. later in the middle of the night 2 or 3 am netcare + 4 or 5 officers knocked on the door pushed my dad out of the way pulled me out of the bathtub + took me to Netcare and then to Twin Valley Behavioral health where I was for 3 1/2 weeks That is where I got my notarized document I'm sending you that I'm representing myself they won't let me have council

There was another incident where I called COSI and left a voice mail if they had a section about the sun and moon + caismic cosmos Netcare came again to my moms house knocked on the door the same way came in my room + pulled me out of bed in July of 2019 about 2 weeks before that I faxed multiple documents census papers that we are a political family about 2 weeks after that which was beginning of July 2019 an officer from internal affairs at police dept. and lady from Netcare crash unit came to my mothers house the officer had a camera on his shirt told me I could get a copy of film anytime I needed it they still won't give me a copy the cop looked at my documents + gave me the impression that the papers was legitimate

The lady from Netcare looked at the same documents that you're looking at and said they were fake. After about an hour of going back & forth to the cruiser she said Netcare wanted to see you. The officer was a nice guy & acted like he didn't want involved in it. So they took me to Netcare and then to hospital for high blood pressure then to River Vista mental health where they stuck 2 needles in me wouldn't let me go till I let them do it after 9 days in there. This is tied to a pink ticket, where they don't have to see a judge or a court

I have at least 30 pages of my records and assessment. The only one who sent my records when I asked for them that it shows that they said I was delusional about being molested in a hospital I was delusional about being from a political family through out history it clearly shows unlawful entry in my home twice. Unlawfully being locked in cruiser 3 times, illegal search in my home unlawful imprisonment slander defimation of character. Every where I have lived these people have stalked me, committed crimes printing up papers and hollering my name Ronnie telling people I done it. Citizens have filed police reports on it. So would you please grant me a writ of Habeas Corpus. Or let me take it to a Jury trial.

I Ronald Bibb would like to represent myself if it has been discovered that I was not released on 1/28/15. On 1/28/15, I want full motion of discovery in any legal documentation accompanied with it, along with any legal and law books and computer system that I might need to defend myself on my case. In addition, I would request paralegal assistant.

I also believe this whole matter is tied to someone trying to steal my inheritance. This also goes in with the identity theft that I believe is going on.

Dear Mr. Bibb:

You contacted Legal Aid for assistance with your Medicaid case. I took your case through our case acceptance process and unfortunately, we were unable to accept your case. You requested a letter explaining how your medication should be paid for.


During our initial phone conversation, you indicated that you are receiving Medicare and that you've been approved for QMB. You also indicated that you have a Medicaid spenddown of \$21. You said that you received a hearing decision last year regarding your spenddown. I found the hearing decision online and it does require JFS to review all of your out of pocket medical expenses and unpaid medical bills to determine how many months you met your spenddown. The decision itself does not determine the number of months of you met your spenddown.

You indicated that your main concern is that your prescription medications are not being covered. As I explained on the phone, Medicare part D should cover your prescription medications. Also, QMB should cover your medicare premiums. So you should have very few out of pocket expenses (besides prescription drug co-pays). Therefore, it should be unnecessary for you to meet your spenddown each month. The only time you may want to try to meet your spenddown is in a month when you need dental or vision care, because those are not covered by Medicare.

If Medicare is not covering your prescription medications, you may want to switch part D plans. To find out which plans cover your medications, you can contact OSHIP at 1-800-686-1578.
