I Ronald Bibb would like to represent myself if it has been discovered that I was not released on 1/28/15. On 1/28/15, I want full motion of discovery in any legal documentation accompanied with it, along with any legal and law books and computer system that I might need to defend myself on my case. In addition, I would request paralegal assistant.

I also believe this whole matter is tied to someone trying to steal my inheritance. This also has to do with the identity theft that I believe is going on.

Dating back to motion of discovery to 1970 from Governor Kasich's, Jobs and family Services, AEP, Columbia Gas, Behavioral Sciences, the mental health board, ADAMH Board. I also would like all medical documents and mental health documents from 1970- to the present.
