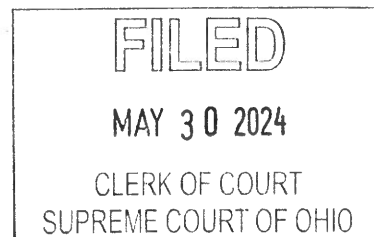

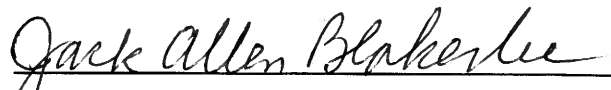

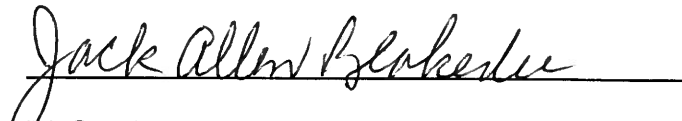

6. The six (6) month suspension ordered November 29, 2023 ended May 27, 2024.

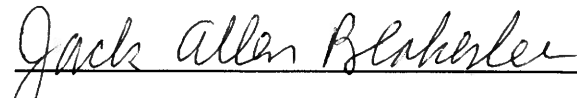

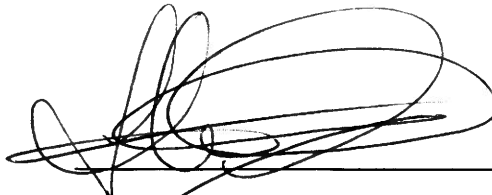
