Facts

On or about October 16th 2024 I, Dustin Barker, submitted a public records request to the Muskingum County Sheriff's Office. The request included:

Incident and use of force reports filed in the past three months.

Personnel records and disciplinary actions taken against deputies or staff over the past three months.

Financial records, including budget reports and expense records, over the past three months. Public complaints and investigations filed against the Muskingum County Sheriff's Office or its deputies over the past three months.

Body camera and dash camera footage from the past three months.

Conflict of interest disclosures or recusals made by deputies or staff over the past three months. Despite multiple follow-ups, the Muskingum County Sheriff's Office has failed to provide the requested records.

Under Ohio Revised Code 149.43, I am entitled to access the requested public records.

Prayer for Relief

Relator prays this court Issue a writ of mandamus compelling the Muskingum County Sheriff's Office to provide the requested records.

Award statutory damages as provided under R.C. 149.43©(2).


