**2008-1568. Greenspan v. Third Fed. Savings & Loan.**

Cuyahoga App. No. 89850, 177 Ohio App.3d 372, 2008-Ohio-3528. This cause is pending before the court as a discretionary appeal and claimed appeal of right. Upon consideration of the motion for admission pro hac vice of Arend J. Abel by Mark Schlachet,

It is ordered by the court that the motion is granted.

**2008-1837. In re Application of Duke Energy Ohio, Inc.**

Public Util. Comm., Nos. 07-589-GA-AIR, 07-590-GA-ALT, and 07-591-GA-AAM. This cause is pending before the court as an appeal from the Public Utilities Commission of Ohio. Upon consideration of the motion of the Ohio Consumers' Counsel for stay of the commission's order and entry,

It is ordered by the court that the motion is denied.

**2009-0585. Profitt v. DaimlerChrysler Corp.**

Cuyahoga App. No. 92509. This cause is pending before the court as a discretionary appeal and claimed appeal of right. On May 8, 2009, appellant filed a notice of suggestion of bankruptcy of Chrysler, L.L.C.

It is ordered by the court, sua sponte, that the parties file memoranda within 14 days of the date of this entry indicating why this case should or should not be stayed pursuant to Chrysler L.L.C.'s filing of bankruptcy. It is further ordered that appellees' memorandum shall have attached a time-stamped copy of the notice of voluntary dismissal of Chrysler L.L.C. that appellees indicate was filed on April 30, 2009.

Portage C.P. No. 95CR220. This cause is pending before the court as a discretionary appeal of the denial of DNA testing. Upon consideration thereof,

It is ordered by the court, sua sponte, that appellee file a memorandum in response to appellant's memorandum in support of jurisdiction within 30 days of the date of this entry.

**2009-0884. State v. Meador.**

Warren App. No. CA2008-03-042, 2009-Ohio-2195. This cause is pending before the court as a discretionary appeal and claimed appeal of right. Upon consideration of appellant's motion for stay of the court of appeals' judgment,

It is ordered by the court that the motion is denied as moot upon the filing of the agreed stipulation between parties to stay proceedings before the Warren County Court of Common Pleas.
