**2009-0430. S. Euclid-Lyndhurst City School Dist. Bd. of Edn. v. Cuyahoga Cty. Bd. of Revision.**

Board of Tax Appeals No. 2006-B-1302. This cause is pending before the court as an appeal from the Board of Tax Appeals. Upon consideration of the joint motion to remand to the Board of Tax Appeals,

### **APPEALS ACCEPTED FOR REVIEW**

**2010-0819. State v. Mbodji.**

Hamilton App. No. C-090384. On July 21, 2010, jurisdiction was declined and this case was dismissed. Sua sponte, the court reconsiders its decision of July 21, 2010, and accepts the discretionary appeal. The Clerk shall issue an order for the transmittal of the record from the Court of Appeals for Hamilton County, and the parties shall brief this case in accordance with the Rules of Practice of the Supreme Court of Ohio.
