2011-1755. Disciplinary Counsel v. Whitfield.

MISCELLANEOUS DISMISSALS

2011-1839. Schafer v. Soderberg & Schafer CPAs, L.L.C.

Ottawa App. No. OT-10-009, 2011-Ohio-4687. This cause is pending before the court as a discretionary appeal and cross-appeal and claimed appeal of right. It appears from the records of the court that the appellees/cross-appellants have not filed a memorandum in support of jurisdiction for their cross-appeal, due November 28, 2011, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore have failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that the cross-appeal is dismissed sua sponte. The discretionary appeal and claimed appeal of right remain pending.
