## MOTION AND PROCEDURAL RULINGS

### **2009-1292. State ex rel. Doner v. Logan.**

In Mandamus. This cause came on for further consideration upon the relators' filing of an unopposed motion for substitution of parties. It is ordered by the court that the motion is granted, and David D. Karr is substituted for Jean Karr as the successor trustee of the Jean A. Karr Revocable Trust.

### **2011-1323. In re Application of Gueli.**

This cause came on for further consideration upon applicant's motion for intervention and applicant's amended motion for intervention. Upon consideration thereof, it is ordered by the court that both motions are denied.

### **2012-0014. Johnson v. Randall Smith, Inc.**

Portage App. No. 2010-P-0050, 2011-Ohio-6000. This cause is pending before the court as an appeal from the Court of Appeals for Portage County.

Upon consideration of appellee's motion to substitute the estate of Jeannette Johnson as appellee, it is ordered by the court that the motion is granted, and the estate of Jeannette Johnson will replace Jeannette Johnson as appellee.

### **2012-1742. State ex rel. Sylvester v. Neal.**

In Mandamus. This cause originated in this court on the filing of a complaint for a writ of mandamus.

Upon consideration of relator's motion to strike the motion to dismiss, it is ordered by the court that the motion to strike is denied. Relator may file a response to the motion to dismiss within 10 days of the date of this entry.

**2011-1921. State v. Sowell.**

Cuyahoga C.P. No. CR-09-530885. This cause is pending before the court as an appeal from the Court of Common Pleas of Cuyahoga County.

Upon consideration of appellant's motion to supplement the record, it is ordered by the court that the motion is granted. The clerk of this court shall supplement the record in this case with the two exhibits attached to appellant's motion to supplement the record.

**2012-2005. LaWarre v. Fifth Third Bank.**

Hamilton App. No. C-110302, 2012-Ohio-4016. This cause is pending before the court as a discretionary appeal.

Upon consideration of the motion for admission pro hac vice of Teresa Verges and Braden W. Sparks, it is ordered by the court that the motion is granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.

**APPEALS NOT ACCEPTED FOR REVIEW**

**2012-1386. Wells Fargo Bank, N.A. v. Messina.**

Geauga App. No. 2011-G-3041, 2012-Ohio-3019. Upon consideration of the jurisdictional memoranda filed in this case, the court declines jurisdiction to hear the case.
