## DISCIPLINARY CASES

### **2010-2203. Disciplinary Counsel v. Raso.**

This cause came on for further consideration upon the filing of an application for reinstatement by respondent, Frank Anthony Raso, Attorney Registration No. 0069270, last known business address in Medina, Ohio.

The court coming now to consider its order of June 22, 2011, wherein the court, pursuant to Gov.Bar R. V(6)(B)(3), suspended respondent for a period of six months, finds that respondent has substantially complied with that order and with the provisions of Gov.Bar R. V(10)(A).

Therefore, it is ordered by this court that respondent is reinstated to the practice of law in the State of Ohio.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.

### **2012-0029. Cincinnati Bar Association v. Hardy.**

This matter is pending before the court upon the filing of a motion to hold respondent in contempt by movant, Cincinnati Bar Association, on January 6, 2012, requesting the court to find respondent in contempt for her failure to comply with an order of the Board of Commissioners on Grievances and Discipline. Respondent did not file a response to the motion. Accordingly, it is ordered by the court, sua sponte, that respondent appear in person before this court on March 21, 2012 at 9:00 a.m.
