DISCIPLINARY CASES

2008-2098. Disciplinary Counsel v. Wolanin.

This cause came on for further consideration upon the filing on September 26, 2012, of a petition for reinstatement by respondent, John Stanley Wolanin, Attorney Registration No. 0051970. In accordance with Gov.Bar R. V(10)(F), respondent's petition for reinstatement was referred to the Board of Commissioners on Grievances and Discipline. The board filed its final report in this court on December 16, 2013, recommending that respondent's petition be denied. No objections to the final report were filed, and this matter was considered by the court.

Upon consideration thereof, it is ordered by this court that the petition for reinstatement of respondent is denied.

It is further ordered by the court that respondent be taxed the costs of these proceedings in the amount of \$1,259.18, less the deposit of \$500, for a total balance due of \$759.18, payable by cashier's check or money order on or before 90 days from the date of this order. If costs are not paid on or before 90 days from the date of this order, interest at the rate of 10 percent per annum will accrue until costs are paid in full. It is further ordered that if costs are not paid in full on or before 90 days from the date of this order, the matter may be referred to the attorney general for collection, and respondent may be found in contempt until all costs and accrued interest are paid in full.

It is further ordered, sua sponte, by the court that within 90 days of the date of this order, respondent shall reimburse any amounts that have been awarded against respondent by the Clients' Security Fund pursuant to Gov.Bar R. VIII(7)(F). It is further ordered, sua sponte, by the court that if, after the date of this order, the Clients' Security Fund awards any amount against respondent

pursuant to Gov.Bar R. VIII(7)(F), respondent shall reimburse that amount to the Clients' Security Fund within 90 days of the notice of that award.

It is further ordered, sua sponte, that all documents filed with this court in this case shall meet the filing requirements set forth in the Rules of Practice of the Supreme Court of Ohio, including requirements as to form, number, and timeliness of filings. All case documents are subject to Sup.R. 44 through 47, which govern access to court records.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.

2008-2493. Disciplinary Counsel v. Ridenbaugh.

On petition for reinstatement of Aaron Anthony Ridenbaugh, Attorney Registration No. 0076823. Petition granted and respondent is reinstated to the practice of law in Ohio.

O'Connor, C.J., and Pfeifer and O'Donnell, JJ., would remand the matter to the board for explanation of the board's recommendation to deny the petition for reinstatement.

2013-0978. Dayton Bar Assn. v. Calaway.

On certification of default. Scott Monroe Calaway, Attorney Registration No. 0068350, is indefinitely suspended from the practice of law.

2013-0999. Disciplinary Counsel v. Deters.

This cause came on for further consideration upon respondent's filing of a motion to modify, in part, the January 27, 2014 order of reciprocal discipline.

Upon consideration thereof, this court orders that the motion is denied.

2014-0253. In re Resignation of Garrison.

On application for resignation from the practice of law of Harold Kevin Garrison, Attorney Registration No. 0062275, and on report filed under seal by disciplinary counsel. Resignation accepted with disciplinary action pending.
