## MERIT DECISIONS WITH OPINIONS

**2017-1416. Cleveland Metro. Bar Assn. v. Horton, Slip Opinion No. 2018-Ohio-2390.**

On Certified Report by the Board of Professional Conduct, No. 2017-011. Debbie Kay Horton, Attorney Registration No. 0033622, last known address in Solon, Ohio, suspended from the practice of law for two years, with one year stayed on condition.

## MOTION AND PROCEDURAL RULINGS

**2017-0877. In re L.G.**

Montgomery App. No. 27296, 2017-Ohio-2781. On motion for admission pro hac vice of Marsha L. Levick. Motion granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days.

**2018-0889. State ex rel. Guest v. Husted.**

In Mandamus. Upon review of the complaint, it is evident that this case was filed more than 90 days prior to the next election and thus should not proceed pursuant to S.Ct.Prac.R. 12.08. Therefore, it is ordered by the court that this case is converted to a standard original action and shall proceed pursuant to S.Ct.Prac.R. 12.04. Respondents shall file a response to the complaint within 21 days.
