## MERIT DECISIONS WITH OPINIONS

**2017-0887. *State v. Amison*, Slip Opinion No. 2018-Ohio-2879.**

Cuyahoga App. No. 104729, 2017-Ohio-2856. Judgment reversed on the authority of *State v. Paige*, \_\_ Ohio St.3d \_\_, 2018-Ohio-813, \_\_ N.E.3d \_\_.

## MOTION AND PROCEDURAL RULINGS

**1998-1970. *State v. Tibbetts*.**

Hamilton C.P. No. B9708596. On appellant's motion for stay of execution. Motion denied as moot.

**2014-0008. *In re Complaint of Allied Erecting & Dismantling Co., Inc. v. Ohio Edison Co.***

Public Utilities Commission, No. 07-905-EL-CSS. On May 11, 2016, this court stayed these proceedings pending resolution of federal bankruptcy proceedings. Sua sponte, the court orders the parties to notify the court within 14 days whether the federal bankruptcy proceedings have concluded and this case can proceed.

**2018-0827. *State ex rel. Miller v. Bower*.**

Franklin App. No. 17AP-456. On appellant's motion for appointment of counsel and motion for mediation. Motions denied.

**2018-0995. State ex rel. Husband v. Shanahan.**

Hamilton App. No. C-180042. This cause was filed as a jurisdictional appeal. It is determined by the court that this cause should proceed as an appeal of right pursuant to S.Ct.Prac.R. 5.01. The clerk shall issue an order for the transmission of the record from the Court of Appeals for Hamilton County, and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 16.02 through 16.07.

**2016-1159. Disciplinary Counsel v. Barbera.**
