Cuyahoga App. No. 107135, 2019-Ohio-458. On appellee's motion to strike notice of appeal and memorandum in support of jurisdiction. Motion denied. Appellee may file a memorandum in response to jurisdiction within 30 days.

2019-0561. State ex rel. Rizvi v. State Med. Bd. of Ohio.

Franklin App. No. 18AP-371. On appellant's memorandum in support of jurisdiction. This cause originated in the court of appeals and should proceed as an appeal of right pursuant to S.Ct.Prac.R. 5.01. The clerk shall issue an order for the transmission of the record from the Court of Appeals for Franklin County, and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 16.02 through 16.07.

DISCIPLINARY CASES

2019-0299. Disciplinary Counsel v. Grego.

On relator's motion to hold respondent in contempt for failure to comply with a January 28, 2019 order by a panel chair of the Board of Professional Conduct to undergo a psychiatric examination. Motion granted. Respondent, Lisa Ann Grego, Attorney Registration No. 0063540, last known address in Bowling Green, Ohio, found in contempt. Respondent suspended from the practice of law in Ohio until proof is filed with this court that she has complied with the panel chair's order.

2019-0449. In re Resignation of Dunn.

On application for retirement or resignation of Marcus David Dunn, Attorney Registration No. 0062732, last known business address in Bexley, Ohio. Resignation accepted with disciplinary action pending.

2019-0450. In re Resignation of Silberman.

On application for retirement or resignation of Marc Norman Silberman, Attorney Registration No. 0010019, last known business address in Cleveland, Ohio. Resignation accepted with disciplinary action pending.
