Because relator Michael R. Cox lacks standing to bring a taxpayer action in support of Count 1, the parties shall not address the merits of the taxpayer action in briefing Count 1.

II and III in accordance with the Rules of Practice of the Supreme Court of Ohio.

The clerk shall issue an order for the transmittal of the record from the Court of Appeals for Monroe County, and the parties shall brief this case on proposition of law Nos. II through V in accordance with the Rules of Practice of the Supreme Court of Ohio.

2020-1250. State v. Brooks.

Richland App. No. 2019 CA 0104, 2020-Ohio-4123. On review of order certifying a conflict. The court determines that a conflict exists. The parties are to brief the issue as stated on page 4 of the court of appeals' October 8, 2020 entry: "Does legislation that shifts the burden of proof on self-defense to the prosecution (2018 H.B. 228, eff. March 28, 2019) apply to all subsequent trials even when the alleged offenses occurred prior to the effective date of the act?" The conflict case is *State v. Gloff*, 2020-Ohio-3143, 155 N.E.3d 42 (12th Dist.). Sua sponte, cause consolidated with 2020-1189, *State v. Brooks*.

Franklin App. No. 19AP-632. On appellants' motion for immediate stay and referral to mediation. Motion denied. Appellee's requests for expedited ruling and for sanctions denied.

Henry App. Nos. 07-19-09 and 07-19-10. On appellant's motion for stay. Motion granted.

O'Connor, C.J., and Kennedy and DeWine, JJ., dissent.

Franklin App. No. 20AP-313, 2020-Ohio-5203. On appellant's motion for emergency stay pending appeal. Motion granted.
