## **MOTION AND PROCEDURAL RULINGS**

**2019-1787. State v. Nicholson.**

Cuyahoga C.P. No. CR-18-634069. On appellant's motion to supplement the record. Motion granted. The Cuyahoga County clerk of courts shall supplement the record with state's exhibit No. 552 in case No. CR-18-634069 within 20 days.

**2021-0847. State ex rel. Marozzi v. Ohio House of Representatives.**

In Mandamus. On relator's application for partial dismissal and notice of partial failure of settlement. Application for partial dismissal granted. Cause dismissed as to the portion of relator's claims challenging respondent's attorney-client-privilege objections. Respondent shall file a response to the remaining portions of the complaint within 21 days.

## MISCELLANEOUS DISMISSALS

### **2021-0113. State v. Biggs.**

Stark App. No. 2020CA00042, 2020-Ohio-6691. On appellant's application for dismissal. Application granted. Cause dismissed.

### **2021-1097. State v. Beasley.**

Monroe App. No. 19 MO 004. On appellant's motion for delayed appeal due to the COVID-19 pandemic. Motion denied as moot. On December 15, 2020, in 2020-1171, *State v. Beasley*, this court declined jurisdiction of an appeal from the same judgment, dated August 14, 2020, currently being appealed. Cause dismissed. No further motions for delayed appeal from the August 14, 2020 judgment entry of the Seventh District Court of Appeals shall be accepted for filing.

### **2021-1129. Catholic Charities Corp. v. Synenberg.**

In Prohibition. On relator's application for dismissal. Application granted. Cause dismissed.
