MOTION AND PROCEDURAL RULINGS

2018-0542. Akron Bar Assn. v. Parkin.

On joint motion to defer monitoring. Motion granted. Respondent shall immediately notify relator once she has registered as active and is planning to return to the practice of law, and the two-year period of monitored probation shall then commence. Within 30 days of respondent's notification, relator shall file with the clerk of this court the name of the attorney who will serve as respondent's monitor.
