# 2021-0441. Disciplinary Counsel v. Ford, Slip Opinion No. 2021-Ohio-3661.

On Certified Report by the Board of Professional Conduct, No. 2020-058. Elizabeth Lorraine Ford, Attorney Registration No. 0068502, last known business address in Cincinnati, Ohio, indefinitely suspended from the practice of law.

Kennedy, DeWine, Donnelly, Stewart, and Brunner, JJ., concur.

O'Connor, C.J., concurs in part and dissents in part and would impose a permanent disbarment.

Fischer, J., concurs in part and dissents in part, with an opinion.

# 2021-0565. State ex rel. Newell v. Cuyahoga Cty. Court of Common Pleas, Slip Opinion No. 2021-Ohio-3662.

Cuyahoga App. No. 110215, 2021-Ohio-1197. Judgment affirmed.

O'Connor, C.J., and Kennedy, Fischer, and DeWine, JJ., concur.

Donnelly, Stewart, and Brunner, JJ., concur in part and dissent in part and would reverse the court of appeals' vexatious-litigator determination.

# 2021-0690. State ex rel. Harrop v. Ohio Adult Parole Auth.

In Mandamus. On respondent's motion to dismiss. Motion granted. Relator's request "to take judicial notice of his PRC notification" denied as moot. Cause dismissed.

# 2021-0773. State ex rel. Cleveland v. Gallager.

In Mandamus and Prohibition. Sua sponte, cause dismissed. Relator's motion for issuance of a peremptory writ of prohibition and writ of mandamus denied as moot. Respondent's motion to dismiss denied as moot. Lieutenant Paul Baeppler's motion to intervene denied as moot.

Kennedy, Fischer, DeWine, Donnelly, Stewart, and Brunner, JJ., concur. O'Connor, C.J., not participating.

# **2021-0804.** LG Chem, Ltd. v. Goulding.

In Prohibition. On respondent's motion to dismiss. Motion denied. Sua sponte, alternative writ granted. The following schedule is set for the presentation of evidence and filing of briefs pursuant to S.Ct.Prac.R. 12.05: The parties shall file any evidence they intend to present within 20 days, relator shall file a brief within 10 days after the filing of the evidence, respondent shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief.

O'Connor, C.J., and Kennedy, Donnelly, Stewart, and Brunner, JJ., concur. Fischer and DeWine, JJ., dissent and would grant the motion on adequate-remedy grounds.

# 2021-0865. State ex rel. Bloodworth v. O'Shaughnessy.

In Mandamus. On respondent's motion to dismiss. Motion granted. Relator's motion requesting entry of default judgment, motion for immediate issuance of a peremptory writ of mandamus, amended motion to strike respondent's motion to dismiss, and amended motion requesting immediate correction of the record and stay pending correction of the record denied. Cause dismissed.
