2023-0788. State ex rel. Taylor v. Montgomery Cty. Court of Common Pleas, Slip Opinion No. 2024-Ohio-1127.

Montgomery App. No. 29735. Judgment affirmed. Appellant's request for oral argument denied.

2023-0862. State ex rel. Townsend v. Gaul, Slip Opinion No. 2024-Ohio-1128. Cuyahoga App. No. 112510, 2023-Ohio-1485. Judgment affirmed. Appellee's motion to strike appellant's exhibits denied as moot.

Summit App. No. 30857. On appellant's motion for all filings to be returned filed time-stamped copied with control number. Motion denied as moot.

Lucas App. No. L-23-1252. On appellant's motion to strike appellee's merit brief. Motion denied. Appellant may file a reply brief within ten days. Appellant's motion for leave to file revised merit brief granted, and revised merit brief deemed filed as of the date of the entry.

2024-0236. In re Comm.'s Investigation into RPA Energy, Inc.

Public Utilities Comm., No. 22-441-GE-COI. On appellee Public Utilities Commission of Ohio's motion to suspend the briefing schedule. Motion granted. Briefing suspended until the court has rendered a decision on appellees' joint motion to dismiss.

2024-0357. Bibb v. Coldwell Bankers H.Q.

In Mandamus. Sua sponte, relator ordered within 14 days to submit a request for issuance of an additional summons at an alternative address or show cause why this case should not be dismissed for failure to perfect service as to respondent Coldwell Bankers H.Q.

Lorain App. No. 22CA011835, 2024-Ohio-503. Appellant's memorandum in support of jurisdiction fails to comply with S.Ct.Prac.R. 7.02(B) (a memorandum "shall not exceed fifteen numbered pages, exclusive of the table of contents and certificate of service"). Sua sponte, pages 14 and 15 of the memorandum in support of jurisdiction, exclusive of the certificate of service on page 15, stricken.
