### MOTION AND PROCEDURAL RULINGS

### 2024-0455. State ex rel. Anderson v. Wilson.

In Mandamus. On relator's motion to strike attorney Matthew P. Convery's motions. Motion denied. Respondents shall immediately serve copies of their motion to dismiss and notice of appearance on relator, and relator may file a response to the motion to dismiss within ten days of the court's entry.

## **2024-0507.** Horton v. State ex rel. Hamilton Cty. Juvenile Court.

In Mandamus and Prohibition. On relator's amended motion to strike. Motion denied. Respondents shall immediately serve a copy of their motion to dismiss on relator, and relator may file a response to the motion to dismiss within ten days of the court's entry.

## 2024-0551. State ex rel. Yost v. Holbrook.

In Mandamus and Prohibition. On motion for admission pro hac vice of Andrew L. Schlafly. Motion granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days.

# 2024-0574. Shamrock Restoration, L.L.C. v. Muncy.

Warren App. No. CA2023-07-056, 2024-Ohio-1002. On appellant's motion for leave to file amendment to motion for stay. Motion granted. Amended motion for stay is deemed filed as of the date of the court's entry.

## **2024-0242.** State v. Blankenship.

Clark App. No. 2023-CA-9, 2023-Ohio-4442. Appellant has not filed a memorandum in support of jurisdiction, due May 16, 2024, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.

## **2024-0245.** State v. Moore.

Montgomery App. No. 29677, 2023-Ohio-4445. Appellant has not filed a memorandum in support of jurisdiction, due May 16, 2024, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.

# 2024-0259. State ex rel. Baker v. Allen Cty. Sheriff's Office.

In Mandamus. Relator has not filed a merit brief, due May 16, 2024, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.

#### 2024-0274. State v. Littler.

Ross App. No. 22CA37, 2023-Ohio-4759. Appellant has not filed a memorandum in support of jurisdiction, due May 16, 2024, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.

#### **2024-0409.** State ex rel. Brown v. Yost.

In Mandamus. On relators' application for dismissal. Application granted. Cause dismissed.

#### **MEDIATION MATTERS**

## **2023-1521.** Cardington v. Fulton.

In Mandamus. Pursuant to R.C. 2710.06(B)(1), the court has been notified that the parties to this case have reached a settlement. The case is returned to the regular docket under S.Ct.Prac.R. 19.01. Relator shall file either an application for dismissal or a notice of failure of settlement within 60 days. The case will be dismissed for want of prosecution if an application for dismissal or a notice of failure of settlement is not filed within 60 days.
