## 2023-1636. State ex rel. Ware v. Sheldon, Slip Opinion No. 2025-Ohio-1768.

In Mandamus. On relator's motion for leave to file additional evidence. Motion denied. Respondent's motion for leave to file additional evidence denied. Writ and relator's requests for statutory damages and court costs denied.

# 2024-1803. State ex rel. Prodigy Bldg. Solutions, L.L.C. v. Dept. of Taxation.

Relator shall file either an application for dismissal or a notice of failure of settlement within 60 days.
