MERIT DECISIONS WITH OPINIONS

2024-0325. State ex rel. Platt v. Montgomery Cty. Bd. of Elections, Slip Opinion No. 2025-Ohio-2079.

In Mandamus. Writ granted in part and denied in part. Relator awarded court costs, \$1,000 in statutory damages, and reasonable attorney fees. Relator shall file an itemized fee application within 20 days, and respondents may file a response within 14 days after the filing of relator's application.

Kennedy, C.J., and DeWine, Brunner, Deters, Hawkins, and Shanahan, JJ., concur.

Fischer, J., concurs in part and dissents in part and would not award statutory damages.

2024-0730. State ex rel. Brown v. Sackett, Slip Opinion No. 2025-Ohio-2080.

In Mandamus. On relator's emergency motion to amend the alternative-writ schedule and motion for an order determining the sufficiency of discovery answers. Motions denied. Writ granted in part and denied in part. Relator awarded \$1,000 in statutory damages. Relator's request for court costs denied.

Kennedy, C.J., and DeWine, Brunner, Deters, Hawkins, and Shanahan, JJ., concur.

Fischer, J., concurs in part and dissents in part and would not award statutory damages.

2024-0858. State ex rel. Fenstermaker v. Phillips, Slip Opinion No. 2025-Ohio-2081.

In Mandamus. Writ denied as moot. Relator awarded \$1,000 in statutory damages. Relator's request for prejudgment interest denied.

Kennedy, C.J., and DeWine, Brunner, Deters, Hawkins, and Shanahan, JJ., concur.

Fischer, J., concurs in part and dissents in part and would not award statutory damages.

2024-1505. In re Application of Duke Energy Ohio, Inc., Slip Opinion No. 2025-Ohio-2082.

Public Utilities Commission, Nos. 22-507-GA-AIR, 22-508-GA-ALT, 22-509-GA-ATA, and 22-510-GA-AAM. On intervening appellee's motion to dismiss. Motion denied.

Kennedy, C.J., and Fischer, DeWine, Hawkins, and Shanahan, JJ., concur.

Brunner, J., dissents and would remand for the commission to substantively address in the first instance the merits of appellant's first rehearing application.
