2024-1756. Jabbar v. Kelley.

In Mandamus and Prohibition. On respondents' motions to dismiss. Motions granted. Relator's motion for leave to amend petition, motion to strike peremptory writ in first instance, and motion to expedite termination of parental rights and adoption of minor child denied. Cause dismissed.

The following schedule is set for the presentation of evidence and filing of briefs pursuant to Rule 12.05: The parties shall file any evidence they intend to present within 20 days of the court's entry, relator shall file a brief within 30 days of the court's entry, respondents shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondents' brief.
