# 2024-0203. State ex rel. Castellon v. Cuyahoga Cty. Prosecutor's Office, Slip Opinion No. 2025-Ohio-2787.

In Mandaums. Writ denied. Relator's requests for awards of statutory damages, court costs, and attorney fees denied.

Fischer, DeWine, Brunner, Deters, Hawkins, and Shanahan, JJ., concur. Kennedy, C.J., concurs in part and dissents in part, with an opinion.
