MOTION AND PROCEDURAL RULINGS

In re Hill.

On September 3, 2020, this court found Tyrice Hill to be a vexatious litigator under Rule 4.03(B) in *State ex rel. Hill v. Navarre*, [2020-Ohio-4274](#). On Hill's motion for leave to file complaint for writ of procedendo. Motion granted. The clerk of court shall file the motion with Hill's complaint for a writ as of September 11, 2025. Hill shall submit the filing fee and security deposit as required by Rules 3.04 and 3.05, or an affidavit of indigence in accordance with Rule 3.06, within 14 days of the court's entry.

In re Tingler.

On March 2, 2023, this court found Charles Tingler to be a vexatious litigator under Rule 4.03(B) in *State ex rel. Tingler v. Franklin Cty. Prosecutor's Office*, [2023-Ohio-640](#); *State ex rel. Tingler v. Franklin Cty. Prosecutor's Office*, [2023-Ohio-641](#) (case Nos. 2022-1612 and 2022-1624). On Tingler's motion for leave to proceed. Motion granted. The clerk of the court shall file the motion with Tingler's complaint for a writ of mandamus and affidavit of indigence, as of September 10, 2025.

Franklin App. No. 24AP-101, [2024-Ohio-4700](#). Sua sponte, appellant's notice of filing supplemental authority stricken for failure to comply with Rule 7.04(A)(2).

In Mandamus. On relator's motion to strike. Motion denied. Sua sponte, relator ordered to file a response, if any, to respondents' motion to dismiss within 10 days of the court's entry.

MISCELLANEOUS DISMISSALS

In Mandamus. On relator's application for dismissal. Application granted. Respondents' motion to dismiss denied as moot. Cause dismissed.

MEDIATION MATTERS

2025-1019. Pointe at Polaris, Phase I, L.L.C. v. Harris.

Board of Tax Appeals, No. 2022-463. On joint motion for referral to mediation. Motion granted. The court refers this case to mediation under Rule 19.01 and stays all filing deadlines for this case until further order of this court. The court will not issue any decision on the merits of this case until mediation has concluded.
