## MOTION AND PROCEDURAL RULINGS

**2025-0091. State v. Mathis.**

Cuyahoga App. Nos. 113678 and 113862, [2024-Ohio-5707](#). On motion of amicus curiae, Ohio Attorney General Dave Yost, to participate in oral argument. Motion granted. Amicus curiae shall share time allotted to appellant.

**2025-1057. Columbus v. State.**

Franklin App. No. 24AP-333, [2025-Ohio-2408](#). On motions for permission to appear pro hac vice of Anthony J. Dick, Noel J. Francisco, and Thomas E. Hopson. Motions granted. Pursuant to Gov.Bar. R. XII(4), counsel shall file notices of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days.

**2025-1102. Davenport v. Progressive Direct Ins. Co.**

Cuyahoga App. No. 114306, [2025-Ohio-2449](#). On motions for permission to appear pro hac vice of Jeffrey S. Cashdan, Nicole Bronnimann, Seth Euster, Zachary A. McEntyre, Paul Alessio Mezzina, Amy R. Upshaw, Allison Hill White, and James Matthew Brigman. Motions granted. Pursuant to Gov.Bar. R. XII(4), counsel shall file notices of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days.

**2025-1124. State ex rel. Finnel v. Dept. of Rehab. & Corr.**

In Mandamus. Sua sponte, it is ordered that within 14 days, relator shall submit a request for issuance of an additional summons at an alternative address or show cause why this case should not be dismissed for failure to perfect service.

### **2025-0937. State ex rel. Muhammad v. Holbrook.**

In Mandamus. On relator's application for dismissal. Application granted. Relator's request for investigation and safety assurances denied as moot. Respondent's motion to dismiss amended complaint denied as moot. Cause dismissed.

### **2025-1050. State ex rel. Bradford v. Zayas.**

In Procedendo. On relator's application for dismissal. Application granted. Respondents' amended motion to dismiss denied as moot. Relator's motion to strike denied as moot. Cause dismissed.

### **2025-1187. State ex rel. Hill v. Sixth Dist. Court of Appeals Judges.**

In Procedendo. On relator's application for dismissal. Application granted. Cause dismissed.
