### **MISCELLANEOUS DISMISSALS**

**2025-1237.** Foster v. McGinty.

Miscellaneous case. Relator did not file a response to the court's December 3, 2025 entry ordering relator to submit a request for issuance of an additional summons at an alternative address or show cause why this case should not be dismissed for failure to perfect service upon respondent. Sua sponte, cause dismissed for failure to perfect service.
