## MOTION AND PROCEDURAL RULINGS

### **In re Robinson.**

On motions for leave to proceed. Motions for leave denied.

### **In re Tingler.**

On motion for leave to proceed pursuant to R.C. 2323.52(F)(2), motion for leave to proceed, and motion for leave due to vexatious-litigator designation. Motions for leave denied.

### **2020-1515. Columbus Bar Assn. v. Chambers.**

On respondent's application for reinstatement. Application denied.

### **2022-0534. Columbus Bar Assn. v. Chambers.**

On respondent's motion to withdraw petition for reinstatement. Motion granted.

### **2024-0257. Voss v. Quicken Loans, L.L.C.**

Hamilton App. No. C-230065, [2024-Ohio-12](#). On motion of amicus curiae Ohio Attorney General Dave Yost to participate in oral argument. Motion granted. Amicus curiae Ohio Attorney General Dave Yost shall share time allotted to appellee.

### **2024-1155. State ex rel. Urban v. Wano Expiditing, Inc.**

Franklin App. No. 22AP-164, [2024-Ohio-2461](#). On appellant's motion to strike. Motion denied. Sua sponte, appellant permitted to file a reply brief within 20 days of the date of the court's entry.

**2024-1689. State ex rel. Hambel v. Franklin Cty. Prosecutor's Office.**

In Mandamus. On motion for leave to file amended answer of respondent City of Columbus, Division of Police. Motion granted. Amended answer of respondent City of Columbus, Division of Police deemed filed.

**2025-0015. Krueger v. Krueger.**

Geauga App. No. 2023-G-0046, [2024-Ohio-2863](#). On appellee's motion to strike. Motion denied. Sua sponte, appellee permitted to file a memorandum in response to jurisdiction within 30 days of the court's entry.

**2025-0143. State ex rel. Sanders v. O'Brien.**

In Prohibition. On respondent's motion to strike or alternative relief. Motion denied. Sua sponte, respondent permitted to file a response to relator's amended complaint within seven days from the date of the court's entry.

**2025-0235. Young v. Hampton.**

Licking App. No. 2024 CA 00043, [2024-Ohio-6081](#). On appellant's motion for leave to file revised memorandum in support of jurisdiction. Motion granted. Appellant's revised memorandum in support of jurisdiction deemed filed as of the date of the court's entry.

## MISCELLANEOUS DISMISSALS

**2024-1628. State v. Cook.**

Richland App. No. 2023 CA 0020, [2024-Ohio-4481](#). Appellant has not filed a memorandum in support of jurisdiction, due February 27, 2025, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.
