The conflict cases are *Hill v. Ferguson*, [2022-Ohio-13](#) (1st Dist.), and *Danison v. Blinco*, [2019-Ohio-2767](#) (3d Dist.). Sua sponte, cause consolidated with case No. [2025-1374](#).

Deters, J., dissents.
