## MERIT DECISIONS WITH OPINIONS

**2025-0262. State ex rel. Boddy v. Xenia Community City School Dist. Bd. of Edn., Slip Opinion No. 2026-Ohio-164.**

In Mandamus. On respondents' first motion for leave to resubmit evidence. Motion granted. Respondents' second motion for leave to resubmit evidence and motion to retrieve attorney-client-privileged materials denied. Writ granted. Relator awarded court costs, \$1,000 in statutory damages, and reasonable attorney fees. Relator shall submit an itemized fee application within 20 days, and respondents may file a response within 14 days after the filing of relator's application.

Kennedy, C.J., and DeWine, Brunner, Deters, Hawkins, and Shanahan, JJ., concur.

Fischer, J., concurs but would not award statutory damages.

**2025-0788. Cincinnati Bar Assn. v. Eppley, Slip Opinion No. 2026-Ohio-160.**

On Certified Report by the Board of Professional Conduct, No. 2024-028. Mark Carter Eppley, Attorney Registration No. 0079218, last known business address in Cincinnati, Ohio, suspended from the practice of law for two years, fully stayed on conditions.

In Mandamus. On respondent's motion to strike relator's motion filed January 2, 2026, for failure to serve. Motion denied. Sua sponte, respondent permitted to file a response to relator's third "motion; excuse respondent counsel: conflict of interest" within ten days of the court's entry.
