2025-1329. Disciplinary Counsel v. Henderson Carter, Slip Opinion No. 2026-Ohio-489.

On Final Report by the Board on the Unauthorized Practice of Law, UPL No. 24-02. Respondent, Pippa Lynn Henderson Carter, enjoined from engaging in the unauthorized practice of law in Ohio. Respondent enjoined from performing notarial acts in Ohio unless and until properly appointed and commissioned as a notary by the Ohio Secretary of State. Civil penalty in the amount of \$30,000 imposed on respondent and ordered to be paid within 30 days. If respondent fails to pay the penalty within 30 days, the matter will be referred to the attorney general for collection and this court may find respondent in contempt. Respondent will be liable for all collection costs pursuant to R.C. 131.02 if the debt is certified to the attorney general for collection.
