2024-0257. Voss v. Quicken Loans, L.L.C., Slip Opinion No. 2026-Ohio-531.

Hamilton App. No. C-230065, [2024-Ohio-12](#). Judgment affirmed in part and reversed in part and cause remanded to the trial court.

Kennedy, C.J., and Fischer, DeWine, Brunner, Hawkins, and Shanahan, JJ., concur.

Lanzinger, J., concurs in part and dissents in part, with an opinion.

In Mandamus. Writ and relator's requests for statutory damages, attorney's fees, and court costs denied.

Fischer, Brunner, and Hawkins, JJ., concur.

Deters, J., concurs in judgment only, with an opinion joined by DeWine and Shanahan, JJ.

Kennedy, C.J., concurs in judgment only in part and dissents in part, with an opinion.

2025-0090. State ex rel. Fenstermaker v. McConville, Slip Opinion No. 2026-Ohio-530.

In Mandamus. Writ and relator's request for court costs denied, and relator awarded \$700 in statutory damages.

Kennedy, C.J., and DeWine, Brunner, Deters, Hawkins, and Shanahan, JJ., concur.

Fischer, J., concurs but would not award statutory damages.

2025-1322. Disciplinary Counsel v. Gernert, Slip Opinion No. 2026-Ohio-529.

On Certified Report by the Board of Professional Conduct, No. 2025-006. Brian Nicholas Gernert, Attorney Registration No. 0089507, last known business address in Bucyrus, Ohio, suspended from the practice of law for two years with 18 months conditionally stayed.

Kennedy, C.J., and Fischer, Hess, Hawkins, and Shanahan, JJ., concur.

DeWine and Deters, JJ., concur in part and dissent in part and would follow the recommendation of the Board of Professional Conduct to impose a conditionally stayed two-year suspension to be served consecutively to the two-year suspension imposed on October 31, 2024.
